	<ul> <li>increased cholesterol increases chance of dying from CVD</li> </ul>		
	<ul> <li>cholesterol concentrations are different in different countries</li> </ul>		
	• same cholesterol level does not confer same risk in different countries		
	• greater the cholesterol to HDL ratio, the greater the risk of CVD		
	• the smaller the diameter the LDL, the greater the risk of CVD		
	• individuals at greatest risk of CVD are those with a large cholesterol to HDL ratio and small LDL diameter and a high cholesterol concentration		
	<ul> <li>not possible to say if different risks for a particular cholesterol concentration in the first study are due to differences in cholesterol to HDL ratio / diameter of LDL</li> </ul>	Allow differences in the first study may be due to differences in cholesterol to HDL ratio / diameter of LDL
