**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

3(a)	1 mark per appropriate term:  Computer 1 and Computer 2 are on the same bus network. Computer 1 sends a message to Computer 2. Before the message is sent, it is split into <b>packets</b> . Computer 1 needs to check that the <b>line / path / bus / channel</b> is free before sending the message, otherwise a <b>collision</b> will occur that will be managed by the <b>CSMA/CD</b> protocol.	<b>4</b>
3(b)	1 mark per bullet point, <b>max 2</b> marks per device:  <b>Router</b> <ul style="list-style-type: none"> <li>• Contains a routing table</li> <li>• ... holds the (private) IP / MAC addresses of the devices on the bus</li> <li>• provides the public IP address for the network</li> <li>• forwards packets to the correct IP / MAC address</li> <li>• may contain a firewall / proxy server</li> </ul> <b>NIC</b> <ul style="list-style-type: none"> <li>• Has a (unique) MAC address</li> <li>• ... to identify a device</li> <li>• Provides a hardware interface // physical connection between computer and network // connection to Ethernet cable</li> </ul>	<b>4</b>

4(b)(i)	1 mark per bullet point to <b>max 4</b> <ul style="list-style-type: none"> <li>• Divide memory / RAM into frames</li> <li>• Divide virtual memory into blocks of same size called pages</li> <li>• Frames / pages are a fixed size</li> <li>• Set up a page table to translate logical to physical addresses</li> <li>• Keep track of all free frames</li> <li>• Swap pages in memory with new pages from disk when needed</li> </ul>	<b>4</b>
4(b)(ii)	First-in-first-out // least-recently-used page // least-used-page	<b>1</b>
4(b)(iii)	1 mark per bullet point to <b>max 2</b> <ul style="list-style-type: none"> <li>• Pages are required back in RAM as soon as they are moved to disk</li> <li>• There is <b>continuous</b> swapping (of the same pages)</li> <li>• No useful processing happens // deadlock</li> <li>• ... (because) pages that are in RAM and on disk are inter-dependent</li> <li>• ... (nearly) all processing time is used for swapping pages</li> </ul>	<b>2</b>

5(a)	1 mark per bullet point to <b>max 2</b> <ul style="list-style-type: none"> <li>Monitoring only gathers information but control systems also perform actions</li> <li>Output in a control system can affect the input</li> <li>There is no feedback in a monitoring system // a control system relies on feedback</li> <li>Example of monitoring applied to the weather station</li> </ul>	<b>2</b>
5(b)(i)	1 mark per bullet point to <b>max 2</b> <ul style="list-style-type: none"> <li>So the readings are stored in <b>chronological</b> order</li> <li>Easy to add / append each new reading to the end of the file // no further processing is required</li> <li>Allows the readings to be read in the order that they were taken</li> <li>Readings do not need to be given further identification as to date / time // no key field needs to be added</li> </ul>	<b>2</b>
