#### PUBLISHED

#### **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

#### **GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

#### **GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always whole marks (not half marks, or other fractions).

#### **GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

#### **GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

#### English & Media subject specific general marking principles

(To be read in conjunction with the Generic Marking Principles (and requiring further guidance on how to place marks within levels))

#### **Components using level descriptors:**

- We use level descriptors as a guide to broad understanding of the qualities normally expected of, or typical of, work in a level.
- Level descriptors are a means of general guidance, and should not be interpreted as hurdle statements.
- Where indicative content notes are supplied for a question, these are *not* a prescription of required content, and must not be treated as such. Alternative correct points and unexpected answers in candidates' scripts must be given marks that fairly reflect the knowledge and skills demonstrated.
- While we may have legitimate expectations as to the ground most answers may occupy, we must at all times be prepared to meet candidates on their chosen ground, provided it is relevant ground (e.g. clearly related to and derived from a relevant passage/text and meeting the mark scheme requirements for the question).

#### **English Language specific marking instructions:**

#### AO1 Read and demonstrate understanding of a wide variety of texts. (Understanding)

- Marks should be awarded for the accuracy of the candidate's understanding of the text and its features, not for any analysis of them which is recognised under AO3.
- Where comparison is required, marks should be awarded for the candidate's recognition of similarities and differences between the texts and their features, **not** for any consequent analysis.
- When awarding a 'best-fit' mark within a Level for each AO, consider each bullet point equally.

#### AO2 Write effectively, creatively, accurately and appropriately, for a range of audiences and purposes. (Writing)

- Marks should be awarded equally on the basis of the level of the candidate's written expression (range of features used and accuracy) and the
  development of their writing (its organisation and relevance to task and audience).
- When awarding a 'best-fit' mark within a Level for each AO, consider each bullet point equally.

#### AO4: Demonstrate understanding of linguistic issues, concepts, methods and approaches. (Conceptualisation)

- Marks should be awarded equally on the basis of the level of the candidate's understanding of the relevant issues, concepts, methods and approaches represented both in the text(s) and in their wider studies.
- When awarding a 'best-fit' mark within a Level for each AO, consider each bullet point equally.

#### AO5: Analyse and synthesise language data from a variety of sources. (Data handling)

- Marks should be awarded equally on the basis of the level of the candidate's selection, analysis and synthesis of language data.
- When awarding a 'best-fit' mark within a Level for each AO, consider each bullet point equally.

Higher marks should be awarded where candidates identify patterns and offer thoughtful and plausible explanations for the features they are discussing.

Weaker answers may spot features or describe individual cases of language change without reference to broader considerations or examples.

	Responses might feature the following:	
	<ul> <li>Lexis and Semantics</li> <li>Gender expectations are made clear in the text through the address to House-wives and Ladies. The writer also refers to having consulted females who have distinguished themselves in domestic roles, whilst the males she has consulted have indisputable judgment and cookery is their publick employment. Candidates may comment on the connotations of the asymmetrical terms Gentlemen and Ladies and the implied social class of the (female) readers. They may also refer to the ngram which shows that these terms are declining in frequency of use, with the lexical items males and females increasing in frequency in comparison.</li> <li>There is a range of verbs and nouns linked to the semantic field of hard work, including endeavours, procuring, prosecute, and exerted. This lexis is still in use today although prosecute now usually has a narrower legal sense, as seen in Text B. She also suggests pride in the work in the lines I flatter myself and I can boast as well as in the use of the adverb ingenuously. The intensifier so is then used to promote the material produced as so well contrived, so useful and so copious.</li> </ul>

1	<ul> <li>In contrast with this confidence, the writer shows a sense of humility in the phrase <i>I may not trefpas too far</i> and signing off with all due Submission and Respect [] Your most humble and obedient Servant. This may be considered to be in line with the expected role of a female writer at this time.</li> <li>The phrase Bills of Fare (to mean 'menus') and the word Compilement (to mean 'collection') have fallen out of use.</li> <li>The noun Receipts is used to mean 'recipes'. 'Recipe' did not become the preferred word until later on, whilst receipt has undergone semantic narrowing and is no longer used in this sense.</li> <li>The compound noun House-wives is more likely to be written without a hyphen by modern writers, perhaps reflecting the tendency over time for compound words to begin by being written with a space, then to be hyphenated, then written solidly without a hyphen. However, Great-Britain is not written with a hyphen nowadays but instead as two words, maybe because 'Great' is an adjective rather than a noun.</li> </ul>	
	<ul> <li>Sentences are often long and complex, making the text seem dense and less accessible by modern standards. Relative clauses contribute to this complexity. Semi colons are used to separate clauses, and in places sentences are started with 'And' which is not considered to be Standard English today.</li> <li>The syntactical structures of the phrases as far as in me lay and this my design are rarely used in modern English: lay comes at the end in the former, and the latter construction uses both this and my where in modern English only one determiner would be used.</li> <li>The text uses the format of a letter and uses some set phrases such as To conclude which give a sense of formality.</li> </ul>	
	<ul> <li>Orthography</li> <li>Archaic spelling in the form of Œconomy (instead of modern day 'economy') and compleat is used.</li> <li>An apostrophe is used for elision of 'though' to tho which would be considered non-Standard today.</li> <li>The spellings publick and Topick for 'public' and 'topic' respectively may reflect issues to do with pronunciation or standardisation of spelling.</li> <li>Verbs with an 'ed' ending are given an apostrophe to form 'd such as in join'd.</li> </ul>	
	<ul> <li>Graphology</li> <li>An illuminated initial is used for the first letter of the main body of text.</li> <li>A long 'j' is used instead of 's' in medial positions in all words and to start words which are not begun with capitals. It is not to be used at the start of common nouns where instead a capital S is used, or at the end of words. This reflects a change in fashion brought about with the development of printing typefaces.</li> <li>Capital letters are not yet standardised and here are used to start the names of nouns which the author considers to</li> </ul>
