General Marking Guidance

- All candidates must receive the same treatment. Examiners must mark the last candidate in exactly the same way as they mark the first.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.
- Examiners should mark according to the mark scheme – not according to their perception of where the grade boundaries may lie.
- All the marks on the mark scheme are designed to be awarded. Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification/indicative content will not be exhaustive.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, a senior examiner must be consulted before a mark is given.
- Crossed out work should be marked **unless** the candidate has replaced it with an alternative response.
- Plans in the lined response area of the question paper/answer booklet should not be marked unless no other response to the question has been provided. This applies whether the plan is crossed out or not.

Specific Marking Guidance

When deciding how to reward an answer, examiners should consult both the indicative content and the associated marking grid(s). When using a levels-based mark scheme, the 'best fit' approach should be used.

- Examiners should first decide which descriptor most closely matches the answer and place it in that level.
- The mark awarded within the level will be decided based on the quality of the answer and will be modified according to how securely all bullet points are displayed at that level.
- Indicative content is exactly that – they are factual points that candidates are likely to use to construct their answer.
- It is possible for an answer to be constructed without mentioning some or all of these points, as long as they provide alternative responses to the indicative content that fulfils the requirements of the question. It is the examiner's responsibility to apply their professional judgement to the candidate's response in determining if the answer fulfils the requirements of the question.

Question Number	Indicative Content
1	<p>Candidates should produce a script to accompany a short video in a style and register suitable for their chosen audience, purpose and context, demonstrating expertise and creativity in their use of English and in their use of the stimulus texts.</p> <p>Candidates' video scripts may be characterised by:</p> <ul style="list-style-type: none"> • the use of conventions of the genre • the script could contain details of visual cues, sound effects or other conventions of screenplays, or could focus entirely on speech/voiceover • predominantly Standard English lexis and grammar • standard use of punctuation • appropriate lexical fields • use of discourse markers to signpost the audience • effective rhetorical techniques to engage the audience • language to create a relationship with the audience • reshaping of material from source texts through techniques, e.g. judicious selection, appropriate quotation or paraphrasing, to generate a new and engaging text. <p>N.B. Candidates must use appropriate material from the source texts in their answers; they may also use information from their own experience.</p>

Question Number	Indicative Content
2	<p>Candidates are expected to produce an analytical commentary that evaluates the language choices made in the production of the creative response to Question 1. Points should be supported by evidence selected from the source texts and the candidate's original writing as appropriate. Candidates should demonstrate understanding of language concepts and issues relevant to the task, applying appropriate terminology to their analysis.</p> <p>The candidates may write about the following analytical frameworks when considering the language choices they have made to create their original writing. These are suggestions only; accept any reasonable analytical approach.</p>
Mode (Method of communication)	<ul style="list-style-type: none"> • script to accompany a short video.
Field (Subject matter)	<ul style="list-style-type: none"> • field of baking, bread and food • field of history • field of culture • field of anthropology • field of mental health and wellbeing.

Function (Purpose)	<p>of the candidate's choosing but may include:</p> <ul style="list-style-type: none"> • to inform the audience about the history of bread and baking • to explain how similar types of bread are made around the world and why • to explore the cultural or sociological significance of bread around the world • to teach viewers how to make bread or encourage them to take up baking • to promote the benefits of cooking or baking as a way to cross cultural divides or to support mental health.
Audience (Relationship between writer/speaker and reader/listener)	<p>of the candidate's choosing but may include:</p> <ul style="list-style-type: none"> • people with an interest in food • people interested in developing their hobby into a business • people with an interest in history, culture or anthropology • people with an interest in mental health and wellbeing • students or schoolchildren.
Context (Issues of production and reception that have influenced content and form)	<ul style="list-style-type: none"> • how the candidate makes use of artistic, technical, social and cultural concepts to shape their text • how the text concedes to the spoken and visual context • how issues of audience and purpose shape the text.
Discourse/pragmatics (How context shapes extended texts and variation in meaning)	<ul style="list-style-type: none"> • how a sense of connection between the speaker and their audience is created • how rhetorical techniques are used to engage the audience • how the generic conventions of a script to accompany a video have shaped the structure and sequence of the text • how the source texts have been reshaped to meet the requirements of the stated audience, purpose and context
	<ul style="list-style-type: none"> • how the experience and knowledge of the audience have been taken into account.
Graphology (Presentation of language)	<ul style="list-style-type: none"> • how appropriate rhetorical devices are used to engage the specified audience • how discourse markers convey shifts in topic how the conventions of a script to accompany a video are applied.
Grammar/syntax (The rules that govern the structure of sentences and the relationships between words in sentences)	<ul style="list-style-type: none"> • how grammatical conventions of spoken language have been used to shape the script how sentence structures have been used to fulfil the purpose of the script and target the chosen audience • how the language of the source materials has been adapted to meet the requirements of the task • how techniques, e.g. direct address or inclusive pronouns, have been used to engage the audience • • how syntax may have a rhetorical function, e.g. tripling, listing, repetition, parallel syntax, contrasting pairs, rhetorical questions • how tense has been varied to manage historical and current perspectives.

Lexis/ semantics (Vocabulary and its meaning)	<ul style="list-style-type: none"> • how the lexis from the source texts has been adapted or incorporated into the script and why how techniques, e.g. imagery, semantic fields and alliteration, have been deployed to fulfil the purpose of the text • how subject specific or specialist lexis has been integrated into the script • how an appropriate register and tone have been established and sustained.

Recalls limited range of terminology and makes frequent errors and technical lapses. • Knowledge of concepts is limited. • Knowledge of issues is limited. • Uses a descriptive approach or paraphrases with little evidence of applying understanding to the reshaping of the source texts. • Lists contextual factors and language features. Makes limited links between these and the construction of meaning in the reshaping of source texts. • Makes limited connections between reshaping of source texts and own writing.
Level 2	7–12	<p>General understanding</p> <ul style="list-style-type: none"> • Uses methods of language analysis that show general understanding. Organises and expresses ideas with some clarity, though has lapses in use of terminology. • Summarises basic concepts. • Summarises basic issues. • Applies some understanding to the reshaping of the source texts. • Describes contextual factors and language features. Makes some links between these and the construction of meaning in the reshaping of source texts. • Makes obvious connections between reshaping the source texts and own writing.
