General Marking Guidance

- All candidates must receive the same treatment. Examiners must mark the last candidate in exactly the same way as they mark the first.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.
- Examiners should mark according to the mark scheme – not according to their perception of where the grade boundaries may lie.
- All the marks on the mark scheme are designed to be awarded. Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification/indicative content will not be exhaustive.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, a senior examiner must be consulted before a mark is given.
- Crossed out work should be marked **unless** the candidate has replaced it with an alternative response.

Specific Marking Guidance

When deciding how to reward an answer, examiners should consult both the indicative content and the associated marking grid(s). When using a levels-based mark scheme, the 'best fit' approach should be used.

- Examiners should first decide which descriptor most closely matches the answer and place it in that level.
- The mark awarded within the level will be decided based on the quality of the answer and will be modified according to how securely all bullet points are displayed at that level.
- Indicative content is exactly that – they are factual points that candidates are likely to use to construct their answer.
- It is possible for an answer to be constructed without mentioning some or all of these points, as long as they provide alternative responses to the indicative content that fulfils the requirements of the question. It is the examiner's responsibility to apply their professional judgement to the candidate's response in determining if the answer fulfils the requirements of the question.

Question Number	Indicative Content
1	<p>Candidates should produce a blog post in a style and register suitable for their chosen audience, purpose and context, demonstrating expertise and creativity in their use of English and in their use of the stimulus texts.</p> <p>Candidates' blog posts may be characterised by:</p> <ul style="list-style-type: none"> • the use of conventions of the genre • lexical and grammatical choices appropriate to their chosen audience, purpose and context • appropriate use of punctuation • use of discourse markers to signpost the reader • effective rhetorical techniques to engage the audience • language to create a relationship with the audience • reshaping of material from source texts through techniques such as judicious selection, appropriate quotation or paraphrasing to generate a new and engaging text. <p>N.B. Candidates must use appropriate material from the source texts in their answers; they may also use information from their own experience.</p>

Question Number	Indicative Content
2	<p>Candidates are expected to produce an analytical commentary that evaluates the language choices made in the production of the creative response to Question 1. Points should be supported by evidence selected from the source texts and the candidate's original writing as appropriate. Candidates should demonstrate understanding of language concepts and issues relevant to the task, applying appropriate terminology to their analysis.</p> <p>The candidates may write about the following analytical frameworks when considering the language choices they have made to create their original writing. These are suggestions only; accept any reasonable analytical approach.</p>
Mode (Method of communication)	<ul style="list-style-type: none"> • Blog post.
Field (Subject matter)	<ul style="list-style-type: none"> • field of ecology and environment • field of the social and economic impact of trees and woodland • field of medicine • field of history and anthropology • field of urban planning.
Function (Purpose)	<p>Of the candidate's choosing but may include:</p> <ul style="list-style-type: none"> • to inform readers about a range of environmental, historical and social issues around trees in urban settings • to educate students • to provide an insight into the benefits of planting trees in cities for a specialist audience • to inspire non-specialist readers to get involved in projects to plant trees in their own towns and cities.
Audience (Relationship between writer/speaker and reader/listener)	<p>Of the candidate's choosing but may include:</p> <ul style="list-style-type: none"> • people with an interest in the social and cultural impact of planting trees or reforestation • people with an interest in the environment or ecology • academics, students or schoolchildren • a specialist audience of ecologists, urban planners, economists or medical professionals • political activists • urban dwellers.
Context (Issues of production and reception that have influenced content and form)	<ul style="list-style-type: none"> • how the candidate makes use of historical, scientific, social and cultural concepts to shape their text • how the text concedes to the written context • how issues of audience and purpose shape the text.

Discourse/ pragmatics (How context shapes extended texts and variation in meaning)	<ul style="list-style-type: none"> • how discourse markers convey shifts in topic • how a sense of connection between the writer and their audience is created • how rhetorical techniques are used to engage the audience • how the generic conventions of a blog post have shaped the structure and sequence of the text • how the source texts have been reshaped to meet the requirements of the stated audience, purpose and context • how the experience and knowledge of the audience have been taken into account.
Graphology (Presentation of language)	<ul style="list-style-type: none"> • use of links to social media or other sections of a website, e.g. drop-downs or menus • use of interactive features, e.g. comments section or polls • how the conventions of a blog post are applied.
Grammar/syntax (The rules that govern the structure of sentences and the relationships between words in sentences)	<ul style="list-style-type: none"> • how grammatical conventions of written language have been used to shape the blog post • how sentence structures have been used to fulfil the purpose of the blog and target the chosen audience • how the language of the source materials has been adapted to meet the requirements of the task • how techniques, such as direct address or inclusive pronouns, have been used to engage the audience • how syntax may have a rhetorical function, employing features such as tripling, listing, repetition, parallel syntax, contrasting pairs, rhetorical questions • how tense and person have been varied to manage historical and current perspectives.
Lexis/ semantics (Vocabulary and its meaning)	<ul style="list-style-type: none"> • how the lexis from the source texts has been adapted or incorporated into the blog post and why • how techniques such as imagery, semantic fields and alliteration have been deployed to fulfil the purpose of the text • how subject specific or specialist lexis has been integrated into the blog • how an appropriate register and tone have been established and sustained.

Level 1	1–6	Descriptive <ul style="list-style-type: none"> • Knowledge of methods of language analysis is largely unassimilated. Recalls limited range of terminology and makes frequent errors and technical lapses. • Knowledge of concepts is limited. • Knowledge of issues is limited. • Uses a descriptive approach or paraphrases with little evidence of applying understanding to the data. • Lists contextual factors and language features. Makes limited links between these and the construction of meaning in the data. • Makes no connections between the data.
Level 2	7–12	General understanding <ul style="list-style-type: none"> • Uses methods of language analysis that show general understanding. Organises and expresses ideas with some clarity, though has lapses in use of terminology. • Summarises basic concepts. • Summarises basic issues. • Applies some of this understanding when discussing data. • Describes construction of meaning in the data. Uses examples of contextual factors or language features to support this. • Gives obvious similarities and differences. Makes links between the data and applies basic theories and concepts.
Level 3	13–18	Clear relevant application <ul style="list-style-type: none"> • Applies relevant methods of language analysis to data with clear examples. Ideas are structured logically and expressed with few lapses in clarity and transition. Clear use of terminology. • Clear understanding of relevant concept. • Clear understanding of relevant issues. • Clear application of this understanding to the data. • Explains construction of meaning in data by making relevant links to contextual factors and language features. • Identifies relevant connections across data. Mostly supported by clear application of theories, concepts and methods.

Controls the structure of response with effective transitions, carefully chosen language and use of terminology. • Discriminating selection of a range of relevant concepts. • Discriminating selection of a range of relevant issues. • Discriminating application of this understanding to the data. • Makes inferences about the construction of meaning in data by examining relevant links to contextual factors and language features. • Analyses connections across data. Carefully selects and embeds use of theories, concepts and methods to draw conclusions about the data.
