# **General Marking Guidance**

- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.
- Examiners should mark according to the mark scheme not according to their perception of where the grade boundaries may lie.
- There is no ceiling on achievement. All marks on the mark scheme should be used appropriately.
- All the marks on the mark scheme are designed to be awarded. Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification may be limited.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, the team leader must be consulted.
- Crossed out work should be marked UNLESS the candidate has replaced it with an alternative response.

12 (a)	As no audience is specified, the examiner is assumed to be the audience.
	Candidates are free to agree or disagree with the statement and may present a variety of arguments.
	Content may include references to: different types of teams (large or small) e.g. school councils, sports teams, action or charity groups, fund-raising committees; the advantages of team work e.g. team spirit, cooperation, pooling ideas and expertise, shared workload, increased motivation; the disadvantages of team work e.g. strong characters may dominate, there could be conflict or disagreement in teams, individuals might make more effort and be more creative.  N.B. Candidates may discuss working as an individual in a positive way.
	Examiners should be open to a wide range of interpretation.

12 (b)	No indicative content can be specified, since candidates may choose to interpret the title as they wish.
	Candidates should be rewarded for such qualities as a sense of drama, vivid description, excitement or suspense.
	Examiners should be open to a wide range of interpretation.
	NB: Explicit reference to the title may not be mentioned until the end of the story.

12 (c)	Candidates may have quite a wide choice of areas – these may be imagined. They may refer to whole neighbourhoods or towns and villages or just a street.
