A man stood upon a railroad bridge in northern Alabama, looking down into the swift water twenty feet below. The man's hands were behind his back, the wrists bound with a cord. A rope closely encircled his neck. It was attached to a stout crosstimber above his head and the slack fell to the level of his knees. Some loose boards laid upon the sleepers supporting the metals of the railway applied a footing for him and his exertions – two private soldiers of the Federal army, directed by a sergeant who in civil life may have been a deputy sheriff. At a short remove upon the same temporary platform was an officer in the uniform of his rank armed. He was a captain. A sentinel at each end of the bridge stood with his rifle in the position known as 'support,' that is to say, vertical in front of the left shoulder, the hammer resting on the forearm thrown straight across the belt – a formal and unnatural position, enforcing an erect carriage of the body. It did not appear to be the duty of these two men to know what was occurring at the centre of the bridge; they merely blocked the two ends of the foot plank that traversed it.

Beyond one of the sentinels nobody was in sight; the railroad ran straight away into a forest for a hundred yards then, curving, was lost to view. Doubtless there was an outpost farther along. The other bank of the stream was open ground – a gentle acclivity topped with a shoulder of vertical tree trunks loopholed for rifles with a single embrasure through which protruded the muzzle of a brass cannon commanding the bridge. Midway of the slope between bridge and fort were the spectators – a single company of infantry in line, at 'parade rest,' the butts of the rifles on the ground, the barrels inclining slightly backward against the right shoulder, the hands crossed upon the belt. A lieutenant stood at the right of the line, the point of his sword upon the ground, his left hand resting upon his right. Examining the group of four at the centre of the bridge, not a man moved. The company faced the bridge, staring silently, motionless. The sentinels facing the bank of the stream, might have been statues to adorn the bridge. The captain stood with folded arms silent, observing the work of his subordinates but making no sign. Death is a dignitary who when he comes announces himself with formal manifestations of respect, even by those most familiar with him. In the code of military etiquette silence and fixity are forms of deference.

The man who was engaged in being hanged was apparently about thirty five years of age. He was a civilian, if one might judge from his habit, which was that of a planter. His features were good – a straight nose, firm mouth, broad forehead, from which his long, dark hair was combed straight back falling behind his ears to the collar of his well-fitting frock coat. He wore a mustache and pointed beard, but no whiskers; his eyes were large and dark gray, and had a kindly expression which one would hardly have expected in one whose neck was in the hemp. Evidently this was no vulgar assassin. The liberal military code makes provision for hanging many kinds of persons and gentlemen are not excluded.

The preparations being complete, the two private soldiers stepped aside and each drew away the plank upon which he had been standing. The sergeant turned to the captain, saluted and placed himself immediately behind that officer, who in turn moved apart one pace. These movements left the condemned man and the sergeant standing on the two ends of the same plank which spanned three of the cross-ties of the bridge. The end upon which the civilian stood almost, but not quite, reached a fourth. This plank had been held in place by the weight of the captain; it was now held by that of the sergeant. At a signal from the former the latter would

step aside, the plank would tilt and the condemned man go down between two ties. The arrangement commended itself to his judgment as simple and effective. His face had not been covered nor his eyes bandaged. He looked a moment at his 'unsteady footing,' then let his gaze wander to the swirling water of the stream racing madly beneath his feet. A piece of dancing driftwood caught his attention and his eyes followed it down the current. How slowly it appeared to move! What a sluggish stream!

You don't know about me, without you have read a book by the name of *The Adventures of Tom Sawyer*, but that ain't no matter. That book was made by Mr Mark Twain, and he told the truth, mainly. I looked at him in astonishment. If ever I saw a man hopelessly hard-up it was the man in front of me. He was ragged and he was dirty, unshaven and unkempt; he looked as though he had been left in a dust-bin for a week. And he was talking to me of the immense worries of a large business. I almost laughed outright. Either he was mad or playing a sorry jest on his own poverty. 5

'If high aims and high positions' said I, 'have their drawbacks of hard work and anxiety, they have their compensations. Influence, the power of doing good, of assisting those weaker and poorer than ourselves, and there is even a certain gratification in display'...

My banter<sup>1</sup> under the circumstances was in every way legitimate. I looked on the purse of the contractor of his appearance and peeped. I was sorry even while I was speaking. 10

He turned a haggard but very composed face upon me. Said he: 'I forget myself. Of course you would not understand.'

He measured me for a moment. 'No doubt it is very absurd. You will not believe me even when I tell you, that it is fairly safe to tell you. And it will be a comfort to tell someone. I really have a big business in hand, a very big business. But there are troubles just now. The fact is ... I make diamonds' 15

'I suppose,' said I, 'you are out of work just at present?'

'I am sick of being disbelieved,' he said impatiently, and suddenly unbuttoning his wrinkled coat he pulled out a little canvas bag that was hanging by a cord round his neck. From this he produced a brown pebble. 'I wonder if you know enough to know what that is?' He handed it to me. 20

Now, a year or so ago, I had occupied my leisure in taking a London Science degree, so that I have an smattering of physics and mineralogy. The thing was not unlike an uncut diamond of the dark sort, though far too large, being almost as big as the top of my thumb. I took it, and saw it had the form of a regular octahedron, with the angled faces peculiar to the most precious of minerals. I took out my penknife and tried to scratch it – vainly. Leaning forward towards the gas lamp, I tried the thing on my watch-glass and scored a white line across that with the greatest ease. 25

I looked at my interlocutor<sup>2</sup> with rising curiosity. 'It certainly is rather like a diamond. But, if so, it is a Behemoth<sup>3</sup> of diamonds. Where did you get it?' 30

'I tell you I made it,' he said. 'Give it back to me.'

He replaced it hastily and buttoned his jacket. 'I will sell it you for one hundred pounds,' he suddenly whispered eagerly. With that my suspicions returned. The thing might, after all, be merely a lump of that almost equally hard substance, o rundum, with an accidental resemblance in shape to the diamond. Or if it was a diamond, how came he by it, and why would he offer it at a hundred pounds? 35

We looked into one another's eyes. He seemed eager, but honestly eager. At that moment I believed it was a diamond he was trying to sell. Yet I am a poor man, a hundred pounds would leave a visible gap in my fortunes and no sane man would buy a diamond by sight from a ragged tramp on his personal warranty only. Still, a diamond that is injured up a value of many thousands of pounds. Then, thought I, a business one would rarely exhibit without being mentioned in every 40



book on gems. I put the question of purchase on one's desk.
