


Proportion of Key Biodiversity Areas (KBAs)\* covered by protected area status, by level of development, 1970–2020

Number of Fairtrade farmers and workers, and total production of selected Fairtrade products, 2016





Satellite images of two areas in the city of Rio de Janeiro, Brazil, an MIC in South America


