**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

1(b)	<p><b>Compare the changes in average calorie consumption per person per day for USA and China shown in Fig. 1.1.</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Both have increased since 1968 – although the starting points are very different</li> <li>• China has increased at a faster rate than USA – China is catching USA up</li> <li>• USA has never been below 3000 kcal – China only got above that in 2009</li> <li>• Overall increase for China (1750 to 3200 est.) is more significant than USA (3000 to 3750 est.)</li> <li>• USA seems to be levelling-off, but China is continuing to increase</li> </ul> <p>Point mark. Maximum 2 marks if no reference to data. Maximum 2 marks if no comparison.</p>	<b>4</b>
1(c)	<p><b>Suggest why an increase in calorie consumption per person per day may create problems for a country.</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Obesity with resulting health issues e.g. diabetes</li> <li>• Health issues creating a strain on health services</li> <li>• Limited amount of food production so where will it come from + impact on farming/environment</li> <li>• Increased costs of supplying the extra calories</li> <li>• Need to import more food – increased costs, potential debt problems</li> <li>• Could increase global warming e.g. increased consumption of beef</li> </ul> <p>1 mark for simple reason or 2 marks if some development such as an example of figures.</p>	<b>5</b>

2(a)	<p><b>Table 2.1 shows the reasons for internal migration for males and females in India, an MIC in Asia, in 2011.</b></p> <p><b>Compare the reasons for internal migration for males and females shown in Table 2.1.</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• The reasons for migration vary significantly between males and females</li> <li>• Men are more likely to migrate for work, 23.9% vs 2.1% for women. The majority of migration for women is due to marriage (66.5%), this is relatively low % for men, around 3.7%.</li> <li>• Both sexes have a fairly low % migrating for education, but again slightly higher in men.</li> <li>• Males undertake more migration to be with family at 34%, nearly twice as much as females.</li> </ul> <p>Maximum 2 marks if no data. Maximum 2 marks if no comparison.</p>	<b>3</b>
2(b)	<p><b>Suggest <u>two</u> reasons for the difference in percentage between males and females moving for work in India as shown in Table 2.1.</b></p> <p>Indicative:</p> <p>Males are more mobile as:</p> <ul style="list-style-type: none"> <li>• Often seen as 'breadwinners' for the family</li> <li>• Cultural pressure</li> <li>• More likely to drive and own cars</li> <li>• More likely to do risky – dangerous/dirty/distant – jobs</li> <li>• Often males are paid more so can afford to move</li> <li>• May be better educated</li> </ul> <p>Females are less mobile as:</p> <ul style="list-style-type: none"> <li>• Often have young children to look after</li> <li>• May lack sufficient education/funds</li> <li>• Expected to marry and settle down</li> <li>• Cultural pressures to not move</li> </ul> <p>Point mark. 1 mark per reason or 2 marks if some development/detail.</p>	<b>3</b>

2(c)	<p><b>Explain why improvements in communications in an area may increase the rate of internal migration.</b></p> <p>Communications can include transport, telecommunications, IT, etc.</p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Reduces the friction of distance</li> <li>• Reduces travel costs (in time/effort)</li> <li>• Supplies more information on destinations to better inform choices</li> <li>• Greater feedback from existing migrants; promotes chain migration</li> <li>• Enables migrants to keep in touch with friends and family</li> </ul> <p>1 mark for simple reason or 2 marks if some development such as an example.</p>	4

3(a)	<p><b>Fig. 3.1 is a photograph which shows a car manufacturing site in Brazil, an MIC in South America, in 2018.</b></p> <p><b>State <u>three</u> different pieces of evidence from Fig. 3.1 which suggest that this is a recently developed manufacturing site.</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Still building – vacant areas to the top right</li> <li>• Buildings look new (clean and fresh)</li> <li>• Vegetation not regrown – bottom left</li> <li>• Not all car storage/parking spaces filled – suggests more to come</li> <li>• Nothing old appears in photograph</li> <li>• Modern layout and design</li> </ul> <p>1 mark per appropriate point.</p>	3
3(b)	<p><b>Suggest why the location of the manufacturing site shown in Fig. 3.1 is suitable for modern-day manufacturing.</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Large-scale site with room for expansion</li> <li>• Large area of flat land to accommodate the big modern buildings</li> <li>• Good road communications – highway top right</li> <li>• Appears to be distant from housing to minimise impact on residential areas (less pollution/congestion)</li> <li>• Space for parking</li> <li>• Can build on greenfield site – no pre-existing buildings to remove or incorporate</li> <li>• Land may be cheaper</li> <li>• Other</li> </ul> <p>1 mark for simple reason or 2 marks if some development/detail.</p>	3

3(c)	<p><b>Explain why services might locate in the central business district (CBD) of urban areas.</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Good access for both workers and customers (transport hub)</li> <li>• Complementarity – services interlink</li> <li>• High demand</li> <li>• High cost of sites can be offset by building upwards</li> <li>• Access to a large number and range of customers (workers/residents/tourists)</li> <li>• Could be near universities etc. to supply skilled workers and/or use services</li> <li>• Anti-pollution laws which improve CBD environment</li> <li>• Demand from government for services</li> <li>• Government incentives/zoning/grants</li> </ul> <p>1 mark for simple reason or 2 marks if some development such as an example.</p>	<b>4</b>

4(a)	<p><b>Describe the changes in the birth rate in the demographic transition model (DTM).</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Stage 1 (High stationary) – BR is high and fluctuates</li> <li>• Stage 2 (Early expanding) – BR remains high</li> <li>• Stage 3 (Late expanding) – BR falling but slowing</li> <li>• Stage 4 (Low stationary) – BR is low</li> <li>• Stage 5 (Declining) – BR falls further or remains low</li> </ul> <p>1 mark per correct change/stage + 2 marks available for use of examples with data.</p> <p>Candidates may not answer with reference to stages, but this may be self-limiting.</p> <p>Candidates may label a diagram with data.</p> <p>No credit for explanation.</p>	<b>7</b>

4(b)	<p><b>With the aid of examples, explain why infant mortality rates fall with the increased economic development of an area.</b></p> <p>Candidates may answer this stage by stage of the DTM or consider the various factors that come with increased economic development:</p> <ul style="list-style-type: none"> <li>• Improvement in diets (quality and quantity) – farming improves</li> <li>• Improved health – medical advances, more hospitals, better health care</li> <li>• Greater security so fewer wars, violence</li> <li>• Improved water supply (quality and quantity)</li> <li>• Greater education on safer living for mothers – anti-smoking, better hygiene etc.</li> <li>• Improved housing – so fewer fires, fewer bugs etc.</li> <li>• Cultural shift such that female children more valued and protected</li> <li>• More years in education means women may have fewer children – fewer children mean a lower IMR</li> <li>• Improved transport so aid can reach problem areas</li> </ul> <p>Award marks based on the quality of explanation and breadth of the response using the marking levels below.</p> <p><b>Level 3 (6–8)</b> Response clearly explains in detail why infant mortality rates fall with the increased economic development of an area. Whichever approach is chosen, essays which address the question and support their argument with relevant examples will be credited. There may be detailed consideration of a case study/one or more examples, or a broadly conceived response, drawing on several examples to illustrate the factors involved.</p> <p>A youthful population impacts on a country via its impact on:</p> <ul style="list-style-type: none"> <li>• Demography – higher BR, lower DR</li> <li>• Social and cultural life – need for schools, health care, type of consumer goods etc.</li> <li>• Political – voting patterns, tax revenue, need for social services/facilities</li> <li>• Economic – both directly e.g. labour supply, cost of childcare, etc. but also indirectly such as increased need for medical care, need for increased size of residential housing, etc.</li> </ul> <p>So is economic the main impact? Are all impacts negative – are there some positives? e.g. increased employment in education.</p> <p>Award marks based on the quality of the response using the marking levels below.</p> <p><b>Level 4 (12–15)</b> Response thoroughly discusses the extent to which the main impact of a youthful population on a country is an economic one. Examples used are appropriate and integrated effectively into the response. Response is well founded in detailed knowledge and strong conceptual understanding of the topic.</p> <p><b>Level 3 (8–11)</b> Response discusses the extent to which the main impact of a youthful population on a country is an economic one but may be unbalanced. Examples may lack detail or development. 5(a)	<p><b>Describe different ways of classifying types of migrants.</b></p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• On cause/reason/motivation: employment, education, forced vs voluntary, pushed vs pulled</li> <li>• On distance: international vs internal (or regional, local etc.)</li> <li>• On direction: rural to urban, intra-urban etc.</li> <li>• On duration: migration vs circulation</li> <li>• On nature of people moving e.g. refugees, legal/illegal</li> <li>• On demographic characteristics e.g. age, sex</li> <li>• On social factors e.g. level of education, family status</li> </ul> <p>Expect at least two ways otherwise a single classification is maximum 4 marks.</p> <p>Point mark. 1 mark per point + 2 marks available for use of examples/details.</p>	<b>7</b>

5(b)	<p><b>With the aid of examples, explain why the level of internal migration has increased in many HICs.</b></p> <p>The HIC context suggests rapidly counter-urbanising countries as well as intra- and inter-urban movements, so level of migration has increased due to:</p> <ul style="list-style-type: none"> <li>• Greater disparities in wealth between areas e.g. rural vs urban or core vs periphery</li> <li>• Increased opportunities in rural areas or cities</li> <li>• Increased separation of work and home locations</li> <li>• Decreased satisfaction with rural or urban life</li> <li>• Improvement in transport – both private and public</li> <li>• Can now work from home (IT)</li> <li>• Increased education – opened up new horizons and ambitions</li> <li>• Growth of media so more people know of other opportunities elsewhere</li> <li>• Government policy – tends to encourage counterurbanisation</li> </ul> <p>Award marks based on the quality of explanation and breadth of the response using the marking levels below.</p> <p><b>Level 3 (6–8)</b> Response clearly explains in detail why the level of internal migration has increased in many HICs. Response is well founded in detailed knowledge and strong conceptual understanding of the topic. Whichever approach is chosen, essays which address the question and support their argument with relevant examples will be credited. There may be detailed consideration of a case study/one or more examples, or a broadly conceived response, drawing on several examples to illustrate the factors involved. Examples can be national or international.</p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• In-migration can be negative for the receiving/destination area depending on the volume and characteristics (e.g. young or old) of the migrants</li> <li>• Economic – strain on services, jobs, housing, food supply etc.</li> <li>• Demographic – higher BR, sex imbalance</li> <li>• Social – unrest, friction with locals</li> <li>• Cultural – differences in religion, diet etc.</li> <li>• Political – may change local voting patterns</li> <li>• In-migration often involves the young, better educated, healthy or wealthy population so can have a positive economic, social and cultural impact</li> </ul> <p>Award marks based on the quality of the response using the marking levels below.</p> <p><b>Level 4 (12–15)</b> Response thoroughly discusses the extent to which the impact of the migration of a population into an area is always negative for the receiving/destination area. 6(a)	<p><b>Describe the causes of re-urbanisation.</b></p> <p>This is about the causes that lead to re-urbanisation (a movement back into urban areas) rather than an explanation of the process as such although these may overlap.</p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Older population moving into urban areas for services/facilities – especially accessible ones</li> <li>• Wealthy moving into older areas – gentrification</li> <li>• Students moving in to be near universities</li> <li>• Young population looking for bright lights/entertainment</li> <li>• Government policy e.g. investment in housing and services</li> <li>• Redevelopment leading to re-imaging of an area</li> <li>• Disadvantages of rural areas</li> </ul> <p>Many may see this in terms of push vs pull factors.</p> <p>Point mark. 1 mark per correct statement + 2 marks available for use of examples.</p>	<b>7</b>

6(b)	<p><b>With the aid of examples, explain the consequences of re-urbanisation.</b></p> <p>Consequences occur both for the urban area and the rural area and can be positive or negative although this may vary between groups/locations.</p> <p>Indicative:</p> <ul style="list-style-type: none"> <li>• Environmental e.g. levels of pollution, congestion levels etc.</li> <li>• Demographic e.g. age/sex ratios, birth rates etc.</li> <li>• Economic e.g. employment, house prices, transport facilities</li> <li>• Social e.g. demand for services, crime levels etc.</li> <li>• Political e.g. voting patterns, type and direction of government investments</li> </ul> <p>Award marks based on the quality of explanation and breadth of the response using the marking levels below.</p> <p><b>Level 3 (6–8)</b> Response clearly explains in detail the consequences of re-urbanisation. Response is well founded in detailed knowledge and strong conceptual understanding of the topic. There may be detailed consideration of a case study/one or more examples, or a broadly conceived response, drawing on several examples to illustrate the factors involved.</p> <p>Political factors cover a wide range of influences and scales e.g. local vs national. Factors could include:</p> <ul style="list-style-type: none"> <li>• Financial e.g. taxation/rates</li> <li>• Planning restrictions/land use zoning</li> <li>• Transport policy e.g. investment in roads/public transport</li> <li>• Investment in services e.g. education</li> <li>• Level of security/safety e.g. policing policy</li> <li>• Development schemes e.g. re-imaging/conservation projects</li> <li>• Impact of conflict</li> </ul> <p>The key element is how these affect the location of activities such as residential, retail, manufacturing etc. within urban areas.</p> <p>Award marks based on the quality of the response using the marking levels below.</p> <p><b>Level 4 (12–15)</b> Response thoroughly discusses the extent to which political factors affect the location of activities within urban areas.
