SCORIS

1. Make sure that you have accessed and completed the relevant training packages for on-screen marking: *scoris assessor Online Training*; *OCR Essential Guide to Marking*.

MARKING

1. Mark strictly to the mark scheme.

5. Crossed Out Responses

Where a candidate has crossed out a response and provided a clear alternative then the crossed out response is not marked. Where no alternative response has been provided, examiners may give candidates the benefit of the doubt and mark the crossed out response where legible.

Rubric Error Responses – Optional Questions

Where candidates have a choice of question across a whole paper or a whole section and have provided more answers than required, then all responses are marked and the highest mark allowable within the rubric is given. Enter a mark for each question answered into RM assessor, which will select the highest mark from those awarded. *(The underlying assumption is that the candidate has penalised themselves by attempting more questions than necessary in the time allowed.)*

Multiple Choice Question Responses

When a multiple choice question has only a single, correct response and a candidate provides two responses (even if one of these responses is correct), then no mark should be awarded (as it is not possible to determine which was the first response selected by the candidate).

When a question requires candidates to select more than one option/multiple options, then local marking arrangements need to ensure consistency of approach.

Contradictory Responses

When a candidate provides contradictory responses, then no mark should be awarded, even if one of the answers is correct.

Short Answer Questions (requiring only a list by way of a response, usually worth only **one mark per response**)

Where candidates are required to provide a set number of short answer responses then only the set number of responses should be marked. The response space should be marked from left to right on each line and then line by line until the required number of responses have been considered. The remaining responses should not then be marked. Examiners will have to apply judgement as to whether a 'second response' on a line is a development of the 'first response', rather than a separate, discrete response. *(The underlying assumption is that the candidate is attempting to hedge their bets and therefore getting undue benefit rather than engaging with the question and giving the most relevant/correct responses.)*

Short Answer Questions (requiring a more developed response, worth **two or more marks**)

If the candidates are required to provide a description of, say, three items or factors and four items or factors are provided, then mark on a similar basis – that is downwards (as it is unlikely in this situation that a candidate will provide more than one response in each section of the response space.)

Longer Answer Questions (requiring a developed response)

Where candidates have provided two (or more) responses to a medium or high tariff question which only required a single (developed) response and not crossed out the first response, then only the first response should be marked. Examiners will need to apply professional judgement as to whether the second (or a subsequent) response is a 'new start' or simply a poorly expressed continuation of the first response.

6. Always check the pages (and additional objects if present) at the end of the response in case any answers have been continued there. If the candidate has continued an answer there then add a tick to confirm that the work has been seen.
7. Award No Response (NR) if:
 - there is nothing written in the answer space

Award Zero '0' if:

- anything is written in the answer space and is not worthy of credit (this includes text and symbols).

1	(a)	<ul style="list-style-type: none"> Which of the following was more important in Japanese foreign relations during the period from 1868 to 1920? (i) Participation in international action in China (ii) The alliance with Britain. Explain your answer with reference to (i) and (ii). In arguing that (i) was of greater importance, answers may refer to the outcome of the Sino-Japanese war, which encouraged western powers to become involved in China. Answers may refer to way the Japanese safeguarded their position by ensuring the security of Taiwan was maintained when western powers were seizing parts of China. Answers may argue that Japan came off worst in the grab for territory and leaders were alarmed at the prospect of a break-up in China. In arguing that (ii) was of greater importance, answers could refer to the alliance of 1902, which was pivotal in Japanese diplomacy for the next twenty years. Answers could argue that it was essential for Japan to be protected against the possibility that other powers might join in if Russia attacked. Answers could consider that Japan was emboldened by the alliance to declare war on Russia, with a good outcome and that the alliance showed Japan was now on equal terms with western powers. 	10	<p>The indicative content lists features of the period studied that relate to the question set.</p> <p><u>Neither significance nor relative importance are attributed to the features listed.</u></p> <p>The indicative content is intended to reflect the knowledge and understanding a candidate is likely to analyse and evaluate in order to arrive at a judgement in line with the question set.</p> <ul style="list-style-type: none"> No set answer is expected Judgement must be supported by relevant and accurate material. 1	(b)*	<p>‘The arrival of US forces under Perry in 1853 was the main cause of tension in the late Tokugawa Japan?’ How far do you agree?</p> <ul style="list-style-type: none"> In arguing that Perry’s arrival did cause tension: Answers may refer to the difficulty the Japanese faced in resisting the US force and the consequent acceptance of a US consul, which was widely resented by national feeling in Japan. Answers may argue that other powers followed suit and demanded privileges, while the failure of the Shogunate to defend Japan increased tension. Answer may argue that warlords who were already hostile to the Shogunate took the opportunity to rebel and proved too strong for the Shogunate to defeat. In arguing that other factors were more important: Answers may argue that social changes had led to the emergence of a merchant class who challenged the power of the samurai, who were viewed as increasingly anachronistic. Answers may argue that peasants often suffered from crop failures and famine and from high levels of taxation which led to peasant uprisings and increased tension. Answers may argue that the corruption and inefficiency in the bureaucracy led to discontent and was a cause of tension. 	20	<p>The indicative content lists features of the period studied that relate to the question set. Both features that support the hypothesis and features that challenge the hypothesis are detailed.</p> <p><u>Neither significance nor relative importance are attributed to the features listed.</u></p> <p>The indicative content is intended to reflect the knowledge and understanding a candidate is likely to analyse and evaluate in order to arrive at a judgement in line with the question set.</p> <ul style="list-style-type: none"> No set answer is expected. Explain your answer with reference to (i) and (ii)</p> <ul style="list-style-type: none"> In arguing that (i) was more important, answers might refer to developments in transport, notably the railways, which led to urbanisation and the emergence of commuters, much as in the west. Answers might argue that technical experts from the west played an important role in industrial growth. Answers might argue that the textile industry developed on western lines and both NEC and Toshiba began as joint ventures with US companies In arguing that (ii) was more important, answers might refer to the influence of Britain in naval development and the sending of promising naval officers to Britain to study. Answers might argue that the early ships were mostly built in British shipyards. Answers might argue that a General Staff was established for the navy following western patterns. 2	(b)*		<p>‘Resentment of western influence was the main reason for the growth of nationalism in Japan during the period from 1920 to 1937.’ How far do you agree?</p> <p>In arguing that western influence was the main factor:</p> <ul style="list-style-type: none"> Answers could argue that Japan was disappointed that there was no racial equality clause in the League of Nations Charter, which seemed discriminatory to them. Answers could argue that the restrictions on Japanese immigration into the US outraged the Japanese and led to greater national feeling. Answers could argue that the signing of the Kellogg-Briand Pact by Japan was attacked by some nationalists Answers could argue that Japan was extremely resentful of western criticisms of its occupation of Manchuria. <p>In arguing that there were other factors:</p> <ul style="list-style-type: none"> Answers could argue that economic problems caused by the Depression and the introduction of Tariffs increased national feeling in Japan. Answers could argue that the army had become more nationalist in outlook and had a special reverence for the Emperor. Answers could refer to the beliefs of Ikki Kita which were used to justify Japanese expansionism and control of East Asia in order to liberate its peoples. Answers could argue that Japanese education promulgated nationalist ideas. 		<p>The indicative content lists features of the period studied that relate to the question set. Both features that support the hypothesis and features that challenge the hypothesis are detailed.</p> <p><u>Neither significance nor relative importance are attributed to the features listed.</u></p> <p>The indicative content is intended to reflect the knowledge and understanding a candidate is likely to analyse and evaluate in order to arrive at a judgement in line with the question set.</p> <ul style="list-style-type: none"> No set answer is expected. At higher levels candidates will focus on ‘main reason’ but at Level 4 may simply list factors. At Level 5 there will be judgement as to the relative importance of factors. 	Generic mark scheme for Question 1(a) and Question 2(a): Which of the following? [10]
Level 6 9–10 marks	Both factors are thoroughly analysed and evaluated using accurate and detailed knowledge and understanding of key features of the period, in order to reach a developed and substantiated judgement in relation to the question.
Level 5 7–8 marks	Both factors are analysed and evaluated using generally accurate and detailed knowledge and understanding of key features of the period, in order to reach a substantiated judgement in relation to the question.
Level 4 5–6 marks	Both factors are analysed and evaluated using relevant knowledge and understanding of key features of the period, however treatment of factors may be un-even with analysis and evaluation of one of the two being only partial. Analysis and evaluation is used to support a reasonable judgement in relation to the question.
Level 3 3–4 marks	Both factors are analysed and evaluated in a partial way, using some relevant knowledge of key features of the period, in order to make a basic judgement in relation to the question.
Level 2 2 marks	Limited and generalised knowledge of the period is used to attempt a limited analysis or evaluation of both factors, and this is linked to a very simplistic judgement.
Level 1 1 mark	Very limited and generalised knowledge of the period is used to attempt a very limited analysis or evaluation of one of the factors. The other factor is either not considered or there is very limited information or description of the factor with no attempt to use this knowledge. If there is a judgement, this takes the form of assertion.

	Generic mark scheme for Question 1(b) and Question 2(b): Essay [20]
Level 6 17–20 marks	There is a consistent focus on the question throughout the answer. Accurate and detailed knowledge and understanding is demonstrated throughout the answer and is consistently evaluated and analysed in order to reach substantiated, developed and sustained judgements. There is a well-developed and sustained line of reasoning which is coherent and logically structured. The information presented is entirely relevant and substantiated.
Level 5 13–16 marks	There is a mostly consistent focus on the question. Generally accurate and detailed knowledge and understanding is demonstrated through most of the answer and is evaluated and analysed in order to reach substantiated judgements, but these are not consistently well-developed. There is a well-developed line of reasoning which is clear and logically structured. The information presented is relevant and in the most part substantiated.
Level 4 10–12 marks	The question is generally addressed. Generally accurate and sometimes detailed knowledge and understanding is demonstrated through most of the answer with evaluation and some analysis, and this is used appropriately to support the judgements that are made. There is a line of reasoning presented with some structure. The information presented is in the most-part relevant and supported by some evidence.
Level 3 7–9 marks	The question is partially addressed. There is demonstration of some relevant knowledge and understanding, which is evaluated and analysed in parts of the answer, but in places knowledge is imparted rather than being used. The analysis is appropriately linked to the judgements made, though the way in which it supports the judgements may not always be made explicit. The information has some relevance and is presented with limited structure. The information is supported by limited evidence.
Level 2 4–6 marks	The focus is more on the topic than the specific demands of the question. Knowledge and understanding is limited and not well used, with only limited evaluation and analysis, which is only sometimes linked appropriately to the judgements made. The information has some relevance, but is communicated in an unstructured way. The information is supported by limited evidence and the relationship to the evidence may not be clear.

Level 1 1–3 marks	The answer relates to the topic but not the specific question. The answer contains only very limited relevant knowledge which is evaluated and analysed in a very limited way. Information presented is basic and may be ambiguous or unstructured. The information is supported by limited evidence.
