# Marking guidance for examiners for Question 1

# Summary of assessment objectives for Question 1

Question 1 assesses assessment objective 2. This assessment objective is a single element focused on the ability to analyse and evaluate contemporary source material in its historical context. The mark awarded to Question 1 is 30.

#### The structure of the mark scheme

The mark scheme for Question 1 has two parts:

- advice on the specific question outlining indicative content which can be used to
  assess the quality of the specific response. This content is not prescriptive and
  candidates are not expected to mention all the material referred to. Assessors
  should seek to credit any further admissible evidence offered by candidates.
- an assessment grid advising which bands and marks should be given to responses which demonstrate the qualities needed in assessment objective 2.

#### Deciding on the mark awarded within a band

The first stage for an examiner is to decide the overall band. The second stage is to decide how firmly the qualities expected for that level are displayed. Thirdly a final mark for the question can then be awarded.

# With reference to the sources and your understanding of the historical context, assess the value of these three sources to an historian studying the problems facd by Charles I before 1640.

Candidates are expected to demonstrate their ability to analyse and evaluate a range of source material with a high degree of discrimination. Source evaluation skills should focus on discussing the strengths and the limitations of the nominated sources. To judge utility, there should be consideration of the content and the authorship of the nominated sources to discuss reliability, bias, purpose and validity, as appropriate.

Candidates will consider the value of the sources to an historian studying the problems faced by Charles I before 1640. Understanding of the historical context should be utilised to analyse and evaluate the strengths and limitations of the sources. Appropriate observations may be made in the analysis and evaluation of the sources including:

- The context of Source A is the King's reliance on favourites from the start of his reign. Charles I is angered by the criticism of his favourite. He defends Buckingham a man he (as had his father) trusts. Charles's reaction is personal and is due in large measure to his belief in Divine Right. He will not accept any criticism. He is well aware of the tension at Court over the favour shown to some and the jealousy this caused in others, most notably the Earl of Pembroke. Charles chose to ignore them whilst issuing threats to those who dared attack his Court favourites.
- The context of Source B is the growing economic crisis of the 1630s especially over Ship Money. Charles I is writing here to a royal official to demand the full payment of Ship Money for the county of Montgomery. The King states the case for the money-the threat of war and invasion-hence the need to build a navy to defend the kingdom. The King is particularly angered at ther paltry sum raised which is well short of the sum at which the county was assessed. He may not trust the sheriff and is keen to have a list of names of those landowners who have refused to pay. The sheriff may be innocent and may be doing his best to raise the unpopular tax from among his friends and neighbours.
- Source C is written by Wentworth, the chief minister and royal favourite of the Crown. He is justifying the King's attitude to and position in relation to Parliament. He does not trust the institution, especially the Commons. Wentworth defends the King's record in government praising its efficiency and effectiveness. Wentworth is biased insofar as he is the man responsible for that government. He may be hoping to gain the support of Manchester and thereby the House of Lords should Parliament ever be recalled. Manchester is being sounded out. The King was short of funds in 1638 and may have contemplated recalling the institution or was being persuaded to do so by Wentworth as was the case eighteen months later.

Overall, candidates will assess the value of the sources to an historian studying the problems facing Charles I before 1640. They are able to demonstrate that value through consideration of the content, provenance and tone of the presented sources with appropriate reference to the historical context linked to the sources.

# Summary of assessment objectives for Question 2

Question 2 assesses assessment objective 3. This assessment objective is a single element focussed on the ability to analyse and evaluate how and why different historical interpretations have been made. The mark awarded to Question 2 is 30.

# How valid is the view that Parliament was mainly responsible for the outbreak of civil war in 1642?

Candidates are expected to show an understanding of how aspects of the past have been interpreted in different ways. Answers will consider the provided material and use their own understanding of the historical context and of the wider historical debate in making their judgement regarding the validity of the view that Parliament was mainly responsible for the outbreak of war in 1642.

Candidates are invited to enter into a debate about whether it is valid to blame Parliament for the outbreak of civil war in 1642. Learners will consider interpretations of this issue within the wider historical debate about the reasons for the outbreak of civil war in 1642. Some of the issues to consider may include:

- Interpretation 1 argues that the King was responsible for the outbreak of war. In analysing and evaluating Interpretation 1 candidates might argue that Seel and Smith's opinion of the King is valid. They suggest that it was the King's belief in Divine Right allied to his poor judgement that was the root cause of worsening relations with Parliament that led in the long term to the outbreak of hostilities in 1642. They are academic historians who are specialists in Stuart political history. They are aware of the wider contemporary context and of the works of other historians of the period. Their research comes sixteen years after that of Lockyer (interpretation 2) who is not a specialist in that particular period in the nation's political history.
- Interpretation 2 argues that Parliament was responsible for the outbreak of war in 1642. In analysing and evaluating Interpretation 2 candidates might argue that Lockyer is a specialist in political history with wider experience than just the Stuart period. He can thus place the events in context and draw on examples from other reigns to help support his opinion. He believes that the majority of MPs were minded to oppose the king and that their motives were aggressive and antagonistic. They were not willing to compromise and can fairly be blamed for pushing the kingdom to war. In short, they backed the King into a corner giving him little choice but to fight.
- Candidates may show awareness of the wider historical debate surrounding the causes
  of the Civil War. In particular candidates should be aware of other interpretations such
  as that the outbreak of war was due as much to the ambitions and machinations of royal
  favourites such as Henrietta Maria, Buckingham, Laud and Strafford or that the tension
  was highlighted by religious and political developments in Scotland and Ireland.

Overall candidates will analyse both interpretations using their own understanding of the historical debate over this issue, offer an evaluation of the validity of the given interpretations and provide a judgement on the issue in the question that Parliament was responsible for the outbreak of war in 1642.
