- William did not think Robert was ready to take control of Normandy and Robert resented his father spending most of his time in Normandy rather than in England.
- William was angry with Robert having been given a castle by Philip II on the border of Normandy, which Robert then used as a base from which to attack William.
- The relationship worsened in the years 1078–1079 when Robert staged a rebellion against William.
- **During Robert's rebellion, William was embarrassed when Robert unhorsed him in battle and William was forced to retreat.**
- **William bullied Robert and gave him the nickname 'Curthose'.**
- Robert resented his father's apparent favouritism towards his brothers, e.g. the failure to punish his younger brothers for playing a trick on him.

Relevant points which support the statement may include:

- The **House of Godwin's** earldom included Wessex, the richest part of England, which had an important role in defending England from attacks from across the Channel.
- By the 1060s, **the granting of earldoms to Harold's brothers Tostig, Gyrth and Leofwine**, meant that the House of Godwin controlled most of England.
- **The Godwins'** control of so much land gave them significant power due to the many thegns under their control whose duties included paying taxation and raising an army.

Relevant points which counter the statement may include:

- King **Edward's marriage to Edith of Wessex** gave the House of Godwin powerful links to the monarchy.
- Harold Godwinson's '**Danish marriage**' gave him support from East Anglia and his later marriage to the sister of the Earl of Northumbria gave support from the north.
- **The House of Godwin gained power in the later years of Edward's reign as** the king became less interested in running the country and Harold acted as sub-regulus.
- The Godwins' military skill, such as successfully defending England against King Gruffydd of North Wales, meant that they were supported by many lords.
- The House of Godwin's power included their strong links with the Church and therefore the support of many influential bishops.

Relevant points which support the statement may include:

- The very rapid building of motte and bailey castles in many parts of England was resented by the Anglo-Saxons who saw this as the imposition of power by the Normans.
- The building of castles in strategically important areas, such as Nottingham and York, was resented as a symbol of Norman power and control.
- Many resented the destruction of homes for the building of castles and local people were often forced to provide services and supplies.

Relevant points which counter the statement may include:

- Land grabs, such as those by Odo, took place in many areas of England and the lack of respect for the new Norman lords led to rebellions.
- Earls, such as Edwin and Morcar, resented their loss of land and status when their earldoms were made much smaller, leading to revolts.
- Many Anglo-Saxons **resented the changes imposed by the Normans, e.g. Hereward the Wake's** rebellion at Ely.
- The heavy geld tax was unpopular and opposed by many who believed it was being used for the benefit of Normandy.
- Many Anglo-Saxons resented the brutal behaviour of many Norman soldiers and the lack of integration by the Normans.
