### Question 1 - 3 marks

- (a) Name one Viking god.
- (b) Name one of the major rivers that Vikings used to sail deep into Russia.
- (c) Give one example of a country that was ruled by King Cnut as part of his empire.

Ireland, Normandy, Poland were not parts of Cnut's empire but paid tribute and therefore cannot be credited with a mark.  Any other historically valid response is acceptable and should be credited.

#### Question 2 - 9 marks

Write a clear and organised summary that analyses Viking contact with the Arab world. Support your summary with examples.

#### Levels

**AO1** Demonstrate knowledge and understanding of the key features and characteristics of the periods studied. **Maximum 6 marks** 

**AO2** Explain and analyse historical events and periods studied using second-order historical concepts. **Maximum 3 marks** 

### Level 3 (7-9 marks)

Demonstrates a well-selected range of valid knowledge of characteristic features that are fully relevant to the question, in ways that show secure understanding of them (AO1).

The way the summary is organised shows sustained logical coherence, demonstrating clear use of at least one second order concept in finding connections and providing a logical chain of reasoning to summarise the historical situation in the question (AO2).

### Level 2 (4-6 marks)

Demonstrates a range of knowledge of characteristic features that are relevant to the question, in ways that show understanding of them (AO1).

The way the summary is organised shows some logical coherence, demonstrating use of at least one second order concept in finding connections and providing a logical chain of reasoning to summarise the historical situation in the question (AO2).

### Level 1 (1-3 marks)

Demonstrates some knowledge of characteristic features with some relevance to the question, in ways that show some limited understanding of them (AO1).

The summary shows a very basic logical coherence, demonstrating limited use of at least one second order concept in attempting to find connections and to provide a logical chain of reasoning to summarise the historical situation in the question (AO2).

# Notes and guidance specific to the question set

Answers should show connections in the situation defined in the question and use these to organise the answer logically.

Answers could consider aspects of one or more of the following: accounts of how the Vikings met Muslim Arabs in southern Russia and central Asia as well as in Muslim Spain and Morocco; how they almost certainly reached Baghdad; the nature of goods they traded; Arab descriptions of Vikings.

Use of conceptual understanding to organise the response might in this case involve similarity and difference and change, e.g. distinguishing by geographical regions, or by time (first contacts and later trade) or by activity.

Answers may show understanding of second order concepts such as causation and consequence (e.g. why Vikings and Arabs met or reasons for actions), similarity and difference within situations (e.g. between the two groups).

Please note that answers do not need to name the second order concepts being used to organise their answer, but the concepts do need to be apparent from the connections and chains of reasoning in the summary in order to meet the AO2 descriptors (see levels descriptors).

No reward can be given for wider knowledge of the period that is unrelated to the topic in the question.

#### Question 3 - 10 marks

What caused Viking raids in the west between 793 and 850? Support your answer with examples.

### Level 5 (9-10 marks)

Uses these to show sophisticated understanding of one or more second order concepts in a fully sustained and very well-supported explanation (AO2).

### Level 4 (7-8 marks)

Demonstrates sound knowledge of key features and characteristics of the period in ways that show secure understanding of them (AO1).

# Notes and guidance specific to the question set

Explanations could consider: the land-hunger theory; climate-change theory; Viking beliefs in the value/virtue of war; reaction to Christian missionary work pressing into Scandinavia; Christians trading on more favourable terms with fellow Christians; the tempting wealth of western churches and monasteries; weakness and division in England / western Europe especially after death of Charlemagne.

Explanations are most likely to show understanding of the second order concept of causation but reward appropriate understanding of any other second order concept.

Answers which simply describe Viking raids cannot reach beyond Level 1.

Demonstrates strong knowledge of key features and characteristics of the period in ways that show secure understanding of them (AO1). Notes and guidance specific to the question set

It is possible to reach the highest marks either by agreeing or disagreeing or anywhere between, providing the response matches the level description.

Answers that seek to agree or disagree strongly with the statement must make it clear that they are not trying to make the same claim for both Scandinavia and the lands where the Vikings settled as there is a strong distinction. (see below). If the answer only considers the Vikings in their homelands or in the lands where they settled, it cannot move beyond Level 3 as they are not showing the "very secure understanding" of characteristic features required at Level 4.

Answers are most likely to show understanding of the second order concepts of change, continuity and causation (when and why the conversions happened) but reward appropriate understanding of any other second order concept.

Grounds for agreeing include: Vikings who had settled in Christian lands did convert quite quickly. Sometimes the conversion was a political move by a leader which could produce very speedy change of religion at one level. Viking traders too might accept Christianity in some measure to gain full trading rights with Christians.

Grounds for disagreeing include: The Viking homelands in Scandinavia were slow to convert to Christianity. Lack of central authority meant any progress was piecemeal according to each local chief. Even if a chief or king did convert for political or religious reasons this did not guarantee Christian dominance and Christianity and



Analysis of the source and interpretations could identify features such as: B and C both show numbers for different years; B gives reason for rising numbers; D may explain why youth joined; identifies "a rapid rise"; notes that the numbers in B and C broadly tally except possibly for 1939.

Understanding of appropriate characteristic features could include: activities of Hitler Youth groups other than those in the collection; how Hitler Youth formed part of wider control of life; other Nazi methods of controlling society.

Limitations that may affect what the source can tell us – would help to know what other reasons Evans gives for rising membership; would help if graph showed proportion of all German youth; existence of poster does not prove that it helped to increase membership.

No reward can be given for raising concerns over the limitations unless this is explicitly used to help to say how it affects usefulness for the context given. Evaluation of usefulness may also involve making valid substantiated suggestions of other lines of enquiry for which the collection may be useful, but the focus given in the

It is possible to reach the highest marks either by agreeing or disagreeing or anywhere between, providing the response matches the level description. To reach Levels 4 and 5, this must involve evaluating how effective opposition was.

Answers are most likely to show understanding of the second order concepts of causation (reasons for resisting or not) and change (rise/fall of Nazi control) but reward appropriate understanding of any other second order concept.

Answers that agree may emphasise the effectiveness of Nazi power subduing any would—be opposition by: the crushing/control of opposition parties, trade unions, churches etc. These answers may also emphasise weaknesses among would—be opponents e.g. divisions among opposition groups; fear of Gestapo and SS; fear of informers; These answers may also argue that low level resistance ("grumbling and joking") does not count as opposition.

Answers that disagree may cover similar territory but with different emphasis e.g. the bravery of low level resistance ("grumbling and joking") does count as effective opposition. Nazi retreat on policies e.g. euthanasia. Opposition kept Gestapo busy by making leaflets, acts of sabotage, secret meetings. Against the background of state and popular pressure of the time, this was significant opposition. War years saw a change – army plots and other assassinations were attempted.

Notes and guidance specific to the question set

It is possible to reach the highest marks either by agreeing or disagreeing or anywhere between, providing the response matches the Level description. In this question, most answers will probably agree and it is hard to imagine how an argument for the west being harsher can be made effectively.

The arguments and supporting evidence will depend on which countries the learner has studied. Accept any valid responses from any countries/regions that match the question.

Responses that only consider the Holocaust as an eastern event cannot access Levels 4 or 5 as this is not "strong knowledge" (Jews from the west were transported to death camps). Answers that consider only the east or the west cannot access Levels 4 and 5 as they fail to answer the question fully if no consideration is given of the other region.

Answers are most likely to show understanding of the second order concepts of similarity and difference (diversity of experience in Nazi held lands) and causation (reasons for these differences but reward appropriate understanding of any other second order concept.

Grounds for agreeing include: the Slavs and other eastern Europeans were seen as racially inferior – not the case in the west; Lebensraum intentions meant Germans expected to occupy the east; pressure to supply German army on eastern front from occupied lands in east; last year of the war saw no relief in east from Allies (unlike west).

Grounds for disagreeing include: atrocities committed in particular places at particular times show "harshness" was


