QUESTION 3

Study the interpretations below and then answer the question which follows.

Interpretation 1

What was the Monkey Trial about? Local businessmen were eager for publicity and extra revenue. William Jennings Bryan, for the prosecution, considered the trial to be about majority rule and democracy. Clarence Darrow, the defence lawyer, saw a chance to completely ridicule Christianity. He shifted the focus of the trial away from democratic issues to a debate about creation and evolution. It was an attack on Christianity.

Interpretation 2

The true importance of the trial was not the verdict. The Monkey Trial increased awareness of the issue of teaching religion and science in public schools. It was not an attack on Christianity and, despite the ruling, the public saw Scopes and supporters of evolutionary theory as the victors in the case.


