1 (a) (i) Value for $d$ in the range $0.15 \mathrm{~mm} \leq d \leq 0.25 \mathrm{~mm}$, with unit.
(c) (ii) Values of $V_{1}$ and $V_{2}$, and $V_{1}>V_{2}$.
(d) Six sets of readings of $l, V_{1}$ and $V_{2}$ scores 5 marks, five sets scores 4 marks etc.

Major help from Supervisor -2. Minor help from Supervisor -1.
Range: $\Delta l \geq 30 \mathrm{~cm}$.
Column headings:
Each column heading must contain a quantity and a unit where appropriate.
The unit must conform to accepted scientific convention, e.g. l/m or $l(\mathrm{~m})$
Consistency:
All values of raw $l$ must be given to the nearest mm .
Significant figures:
Significant figures for every row of $V_{1} / V_{2}$ must be the same as, or one more than the least number of significant figures used in $V_{1}$ and $V_{2}$.

Calculation:
Values of $V_{1} / V_{2}$ calculated correctly.
(e) (i) Axes:

Sensible scales must be used, no awkward scales (e.g. 3:10).
Scales must be chosen so that the plotted points occupy at least half the graph grid in both $x$ and $y$ directions.
Scales must be labelled with the quantity that is being plotted.
Scale markings should be no more than three large squares apart.
Plotting of points:
All observations in the table must be plotted.
Diameter of plotted point must be $\leq$ half a small square (no "blobs").
Work to an accuracy of half a small square.
Quality:
All points in the table must be plotted on the grid for this mark to be awarded.
All points must be within 0.05 (to scale) on the $y$-axis $V_{1} / V_{2}$ from a straight line.
(ii) Line of best fit:

Judge by balance of all points on the grid about the candidate's line (at least 5 points) There must be an even distribution of points either side of the line along the full length. Allow one anomalous point only if clearly indicated by the candidate.
Line must not be kinked or thicker than half a small square.

(iii) Gradient:

The hypotenuse of the triangle must be at least half the length of the drawn line.
Both read-offs must be accurate to half a small square in both the $x$ and $y$ directions.
The method of calculation must be correct.
$y$-intercept:
Either:
Check correct read off from a point on the line and substituted into $y=m x+c$.
Read-off must be accurate to half a small square in both $x$ and $y$ directions.
Or:
Check read-off of the intercept directly from the graph.
(f) (i) Value of $P=$ candidate's gradient. Value of $Q=$ candidate's intercept.
(ii) Value of $\rho$ in range $1.0-20.0 \times 10^{-7} \Omega \mathrm{~m}$

2 (b) Value of $m$ to the nearest 1 g or better with consistent unit.
(c) (ii) Measurement of raw $\theta$ to nearest degree with unit.

Evidence of repeat readings for $\theta$.
(iii) Percentage uncertainty in $\theta$ based on absolute uncertainty of 2 to $5^{\circ}$ (or half the range provided this is not zero), and correct method of calculation.
(iv) Correct calculation of $\tan (\theta / 2)$.
(d) (i) Second value of $m>$ first value of $m$.
(ii) Second value of $\theta$.

Quality: second value of $\theta<$ first value of $\theta$.
(e) Value of $\theta$.
(f) (i) Two values of $k$ calculated correctly.
(ii) Justification of s.f. in $k$ linked to significant figures in $m$ and $\theta$.
(iii) Sensible comment relating to the calculated values of $k$, testing against a criterion specified by the candidate.
