













17 A student carried out an experiment to determine the Young modulus of a material in the form of a wire. The wire was suspended from a rigid support and weights were added to the free end. The corresponding extensions Δl were determined.

The diagram shows how an optical lever was used to measure the extension of the wire. The light from a laser was reflected by the mirror and moved upwards a distance Δy along a vertical scale as the wire extended. The distance D from the mirror to the scale and the length d of the pivoted arm were measured.



The following formula was used to determine a precise value for the extension of the wire Δl .

$$\Delta l = \frac{d\Delta y}{2D}$$

Before the weights were added to the wire, the student measured the diameter and the original length of the wire.




