Then the ratio of $\frac{V}{I}$ increases (accept gradient decreases) as pd increases. This is because the resistance increases as the temperature of the filament increases. Electrons experience a force when a pd is applied across a conductor which accelerates them towards the positive of the pd. This is a non-random movement (called drift velocity) and is the basis of current. The drift continues until the electron collides with the vibrating lattice. These collisions provide a resistance to the mean drift movement of the electrons. The collisions cause the temperature of the wire to increase. As the temperature increases the lattice ions vibrate with a greater amplitude and the electrons travel faster, so decreasing the mean time between collisions.
