- contextual factors.




FIG 10.4 Righthand front brake assembly

10.4 The Front Brakes (An assembled righthand brake is shown in FIG 10.4)

Removing and replacing the shoes:

- 1. Firmly apply the handbrake, jack up the front of the car after slackening the wheel nuts. Support the car on stands or blocks and remove the road wheels.
- 2. Slacken back the adjustors. Take out the countersunk securing screw and withdraw the brake drum from the assembly. Hold the steady posts, press in the leaf springs B and slide them sideways to remove them from the steady posts. Withdraw the steady posts from the rear of the backplate.
- 3. Lift one brake shoe from the slot in the wheel cylinder and disconnect the return spring from the backplate. **Do not press the brake pedal when the shoes are removed.** Replace the shoes in the reverse order of removal.
