Answer all parts of Question 1.

- 1 (a) Study Fig. 1, which shows percentage change of population in rural areas of England between 2001 and 2015.
 - Use **one** piece of evidence from **Fig. 1** to show how shifting flows of people have shaped the demographic profile of rural areas in England. [3]
 - (b) Study Fig. 2, which shows cyclical economic change in the UK between 1978 and 2017.
 - Using evidence from **Fig. 2**, suggest how cyclical economic change can have varied social impacts. [8]
 - (c) Suggest two ways that time-space compression can influence our sense of place. [6]
 - (d)* 'Successful rebranding of a place is rarely the product of a single strategy.' To what extent do you agree? [16]

 - (ii) Give **two** limitations of the interquartile range in describing the spread of data in **Fig. 3**. [2]
 - (b) Explain how two different types of human rights violation can be a cause of conflict. [5]
 - (c) With reference to a **case study** of **one** country, explain the strategies used to address gender inequality issues. [8]

- 5 (a) Study Fig. 4, which shows the number of personnel deployed in selected UN Peacekeeping operations, 2018.
 - (i) Calculate the interquartile range for the data in Fig. 4. You must show your working. [2]
 - (ii) Give **two** limitations of the interquartile range in describing the spread of data in **Fig. 4**. [2]
 - (b) Explain how two different types of threat to territorial integrity can be a cause of conflict. [5]
 - (c) With reference to a **case study** of **one** country, explain how challenges to its sovereignty can have impacts on people. [8]
